- Qualified Principal and faculty is to be appointed as per NCTE norms and University rules.
- These Colleges should have Library, Laboratories, Computer Lab and other infrastructure requirement as per the NCTE and University norms.
- The University inspection committee will inspect/reinsert the college and if the proper requirements are not found, the above permission shall be treated as withdrawn.
- This NOC is purely provisional and subject to the fulfillment of all the conditions laid down by the NCTE, State Government and University Affiliation rules.
- The University has legal rights to withdraw affiliation of the college any time, if the conditions are not found satisfactory.
- These colleges if not found proper will have to go through re-inspection and the re-inspection fee will to be deposited by the concerned colleges within a month to complete the deficiencies pointed out to them.
- All the requirements will have to be completed within two months' time.
